

# Bed Bug Free™

## Mixing Directions

Add 1/2 oz. of concentrate into 127.5 oz. of water to make 1 gallon of ready to use product. Shake and pour into desired sprayer. For best results we recommend using an electric actisol or similar type of sprayer. Once sprayer is empty rinse with warm water. **This 32 oz. container will make 64 gallons of ready to use product.**

### For Bed Bug Use:

Before spraying mattresses, remove all linens and place in plastic bags for proper disposal. Once removed spray directly on the mattress, frame, foot and head boards. Make sure to get in all creases and seams. Completely saturate without dripping. Be sure to flip mattress and do both sides. When dry vacuum all the dead remains. Re-apply as necessary. Can be sprayed directly on rugs. Product can be used in rug shampoo machines. Thorough coverage and accuracy are key to elimination.

### For Roach Use:

Spray directly in infested areas including but not limited to under sinks and tubs, in cabinets and food pantries (may require food removal or disposal). Behind appliances (refrigerator, stove, including counter top appliances). Any place there is a food source. Can be sprayed in clothes closets, clothing bins, and dressers draws. It is also recommended to spray the perimeter of the rooms. Re-apply as often as necessary. Can be sprayed directly on rugs. Product can be used in rug shampoo machines.
